We have received the accounts and financial report from our treasurer **Jen Dale**. She has answered our questions. We accept the accounts and financial report for **2025**.

We thank Jen Dale for years of service as our treasurer and are grateful that she is working together with our incoming treasurer River~~ during the transition between treasurers.

#### 26/03/5 Bank Account

We have received a paper from River~~ about changing our main bank account from the Cooperative Bank to the Metro Bank. We discussed and identified several issues that such a move would involve. We defer this item to our next meeting for worship for business and ask our treasurer River~~ and the clerk to bring a new paper on the proposed move.

In the meantime, we we ask our outgoing treasurer Jen Dale to start the process to make River~~ the main contact and signatory for our Co-op account.

#### 26/03/6 Change of Signatory for Co-operative Bank Account

We agree that as our new treasurer our Friend Keith Harold Wright should become the main contact and signatory for our bank account with the Co-operative Bank.

#### 26/03/7 Premises Update

We have received a short update from our Premises Committee. The new boiler has been installed and seems to be working well. We thank Jackie Barker, the Premises Committee and our wardens for their hard work on our behalf in resolving the boiler issue so quickly and smoothly.

### **26/03/8 Beehive for the Garden**

**We** have received a paper on enable a young attender to set up a beehive in the meeting house garden. **We** accept this proposal and welcome this use of our meeting house garden and the proposed arrangements for maintaining the beehive.

### **26/03/9 Collections**

**We** have collected the following amounts for our chosen causes in recent months (see attached paper):

**We** have discerned to collect for Human Rights Protection Fund in April, for the Glossop Arts Project in May, and the Little Rebels Book Award in June.

**We** will collect the suggestions for collections in July, August in September from the beginning of April. **We** might give priority for Quaker charities or organisations at that time.

At our meeting in January, we agreed to screen The Narrow Bridge. Our clerk has been in touch with the film's producers and distributors. Showing the film involves a fee of Au\$360 (roughly GBP 190) less if shown by a charity. We have consider this and ask our clerk to negotiate a lower charity fee based on the likely audience and bring this item back to us.

### **26/03/12 World Day of Prayer**

We hosted the annual World Day of Prayer service organised by Disley Churches. Thirty people came to the service and enjoyed cake afterwards. We thank Anne Sumner and Ann Lewis for hosting the event and organising tea and cake for those attending.

### **26/03/13 Quiet Garden Day in June**

We have received a proposal for a Quiet Garden Day in June from our Gardening Group. This event will be for Friends from our Meeting and possibly the Area Meeting to enjoy the garden. Elders have considered this proposal and are supportive. We agree to this proposal and are grateful to the Gardening Group for this initiative.

Our Nominations Committee has been unable to find names for the role of elder and assistant clerk after diligent searches.

After careful consideration, Nominations Committee asks to discontinue these searches at present. We thank them for their hard work and extensive search.
